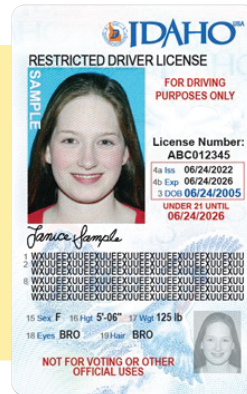

Why is this Good for Idaho?

- All Idahoans are protected
- Proper training for everyone behind the wheel
- Licensed drivers equals safer roads
- Limited disclosure of personally identifiable information by those that desire privacy



Cost

- The RDC Program will be revenue generating:
- A \$50 biannual fee covers the cost of the program
- Additional funding from titles and registration brings in \$700,000 over 30 months



Limitations

- Cannot be used to vote
- Cannot be used to buy firearms
- Cannot be used to exercise any rights or privileges reserved for citizens



Road Safety

- Accidents are 3x deadlier when driver is unlicensed
- Unlicensed drivers are 9.5x more likely to run in an accident
- Property damage claims are >\$22,000 higher when driver is unlicensed
- Increase in proper training for drivers



Expectations

- Idaho can expect to see the following:
- Fewer traffic injuries
- Drop in number of hit and runs
- Decrease in number of alcohol related crashes
- Lower rate of uninsured drivers
