The Farm Bureau Woman of the Year is open to all regular Farm Bureau member families to honor one of the hard-working Farm Bureau women with special recognition. The award is sponsored by the Women's Leadership Committee of the Idaho Farm Bureau to recognize, encourage and celebrate the achievements of women in agriculture. Created to honor individuals who attain and personify the highest level of professional excellence, the award also celebrates the potential of all women as valuable members and leaders in agriculture and their community.

CRITERIA

- ✧ Demonstrates support of the goals of Farm Bureau and provides unselfish assistance in their behalf.
- ✧ Provides valuable service to farming/ranching and to the community.
- ✧ Exhibits initiative and creativity enhancing the strength of farming/ranching.
- ✧ The member family must be actively engaged in farming. Any Idaho Farm Bureau member family in which the husband is retired or deceased, are also eligible.
- ✧ According to the rotation established, the Farm Bureau Woman of the Year nomination is submitted to the District Women's Leadership Chairman. As the District Farm Bureau Woman of the Year, she will be honored at the Annual Meeting of the Idaho Farm Bureau.
- ✧ A DVD will be produced of each District Farm Bureau Woman of the Year and shown at the Annual Meeting.
- ✧ The Women's Leadership Committee will cover one night's lodging, awards luncheon or banquet and breakfast or annual banquet with 2 tickets. (Meals will be determined by when Awards are given.)
